Whatever fun and imaginative way you decide to fundraise, you must ensure you have taken the following in to consideration:

**Asking for permission:** If you are planning a collection in a public area or private property you must always run this by your local authority, the land owner or community officer. If you are planning on a set up with an activity (like an exercise bike or running machine) please ensure you have checked this out, sometimes you need a license/ certain permissions to do this.

**Be Obvious & Get Creative:** Make it obvious and stand out. Make sure you have fundraising literature explaining what you are doing and who you are doing this for. Pick a great spot where you will get noticed. Be creative and create posters and flyers to show off in local shops and businesses. You could purchase an embroidered jumper or polo shirt from our shop to help you stand out.

**Local News:** You may have a local newspaper or local community radio station you could involve, they are usually looking for positive and inspirational local news that could help you raise awareness.

Make sure whatever you choose to do you make it FUN, smile and enjoy it.

# IMPORTANT THINGS TO CONSIDER:



**Auctions, Lotteries & Raffles**: These are all great way to raise funds and awareness, however, before considering these as a means to fundraise, please check the specific laws around them, you can do this by checking the latest advice from The Gambling Commission here: www.gamblingcommission.gov.uk

**Insurance for your Event:** If you are holding an event at a venue it is always best practice to check with the venue management whether insurance is included.

We are unable to cover you with any insurance ourselves for your event, we would recommend you speak with an insurance company to ensure you have the correct cover.

The most common insurances needed for an event are:

- Event / Venue Cancellation Insurance.
- Public Liability INsurance.
- Damages to Property.

**Pubilc Collections & Bag Packing**: If you are considering collections in a public place you must first seek permission from your local authority or council licensing officer, this is important as it could result in a fine.

If you are considering collections in a supermarket or private area within your town, you will need the venues management team to authorise this.

Make sure, once you have the go ahead you let us know where you will be, we can offer support and help raise awareness once permissions have been granted.







## GIFT AID, WHAT IS IT AND HOW DOES IT WORK?

For every £1 donated, we can claim 25p from the Government at no extra cost to you or your support network.

This means that a £20 donation is worth £25.

Gift Aid is a Government scheme which enables registered charities in the UK to claim backtax from HMRC on donations made.

The opton to add Gift Aid is on our sponsor forms and Enthuse Fundraising site. It is an simple way for a UK taxpayer to increase their donations with no extra cost to them. Gift Aid can only be claimed on personal donations. It is not possible to claim on behalf of a company or group donation.

Please be advised Gift Aid cannot be added to your fundraising total but only on individual donations that qualify.
